



## 2021 Membership Information and Fee Schedule

Membership at Morningstar Golf Club is an annual commitment for the period **December 1 to the following November 30 each year**. It includes unlimited golf in the category of choice, two week advance tee time booking privileges, special rates for Member's guests, Member rates for golf car rentals, and services that are for Members only on an optional basis (bag storage is limited in number and issued on a first come first served basis, annual car rentals) as well as Member accounts. It also includes complimentary range balls. Because the range is so busy there will occasionally be limitations on the size of baskets distributed.

In 2020 some people joined the Club after it re-opened following the COVID closure. Rates were prorated for them based on the number of months left in the season. That was done to encourage people to return to Morningstar, or to join for the first time and help us grow the membership. Pro-rating fees may occur in the future for new members joining after June 1 in any given year, providing there is space available. We anticipate capping the membership and instituting an entrance fee for new members at a future date.

Golf Canada membership is also included. Individual members may log in to their Golf Canada account and order their membership card, bag tag and golf club identification shaft bands, and they will be mailed directly.

In past years there has been a nine-month (snowbird) membership category. That is no longer available going forward. As mentioned earlier, membership is an annual commitment with annual benefits. We have added an afternoon membership category which allows for play after 1 PM in the afternoon. We have also chosen to implement a new fee payment plan. New just this month in Lightspeed software is the ability for members in the same family to combine accounts into one master account.

With the renewal of the membership for 2021 a payment equal to 15% of the total will be required upon renewal by December 1. This can be made by credit card, debit card, cheque, or cash. Each Member's credit card information will be entered into STRIPE, a secure, off site card processor. This ensures that card information is not stored on site and will also save considerable hours of onsite bookkeeping time. Members will receive their account statement by email on the first of each month showing all charges from the previous month, including the monthly dues charge. This allows for time to resolve questions or correct any errors and the credit card will be charged on the 15<sup>th</sup> of the month. The balance of the dues will be billed to the Member's account each month, December through September (10 months).

Our vision is to work with new owners to continuously improve the facilities and services at Morningstar Golf Club, so it regains its former glory.
